DESCRIPTION

A detached steel portal frame industrial unit with block/brickwork elevations and profile steel cladding to the upper parts. The property comprises an industrial/storage area with single storey extension to the front of the building, providing air conditioned offices, a kitchen and toilets. The property has a loading door to the side elevation with access to the side to a secure rear yard area.

LOCATION

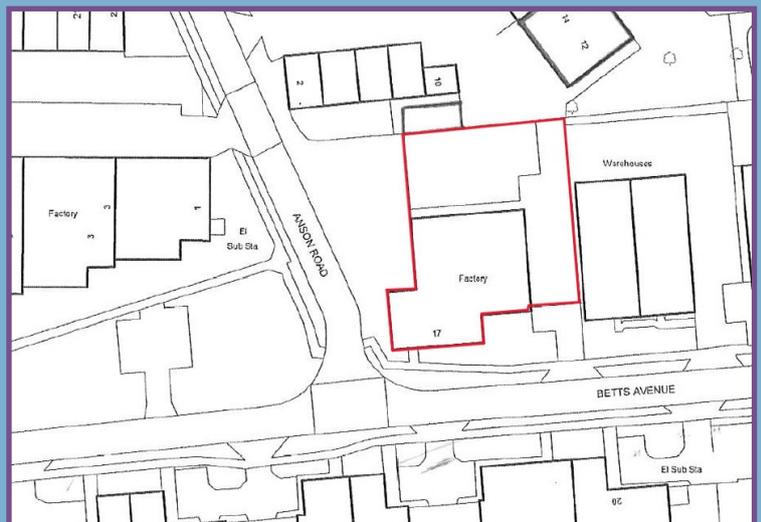
Ipswich is the County town of Suffolk with a population of approximately 130,000 and a catchment area of over 250,000. It occupies a strategic position close to the International Container Port of Felixstowe and the interchange of the A12 and A14 trunk roads. Martlesham Heath Business Park is located adjacent to the A12 dual carriageway in close proximity to Junction 28 of the A14. The Estate, together with the adjoining retail park, comprises of a variety of occupiers including Ladbrokes, Howdens, Orwell Trucks and Jewson.

ACCOMMODATION

The premises provide the following approximate floor areas:

Ground Floor: 615.94 m² 6,630 sq ft
Areas provided are on a Gross Internal Area (GIA) basis.

Eaves height: 2.82m to underside of the roof.



TERMS

The property will be available in **March 2026** on a new FRI lease for a term of 5 years at a rental of £8.52psf (£56,500 pax). Rents are exclusive of estate service charge, buildings insurance and VAT which are payable quarterly in advance.

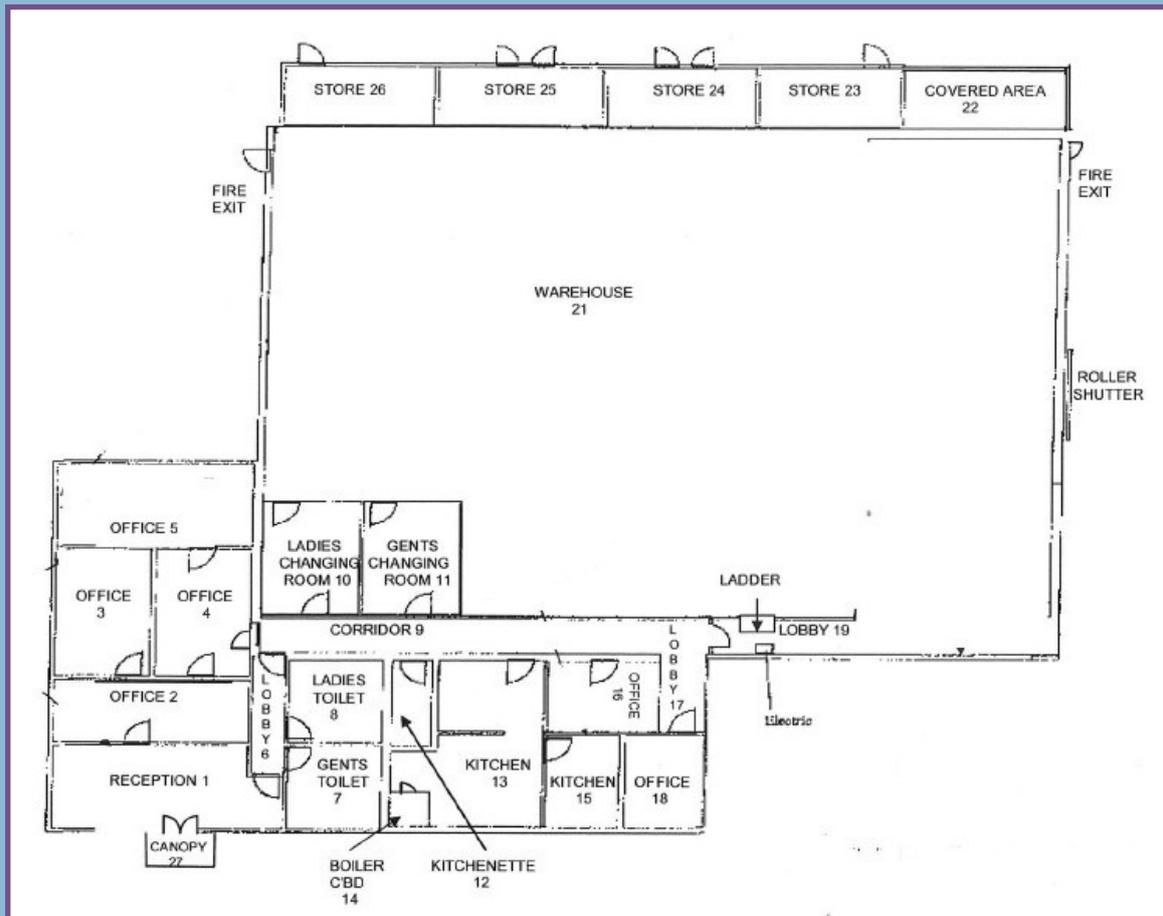
